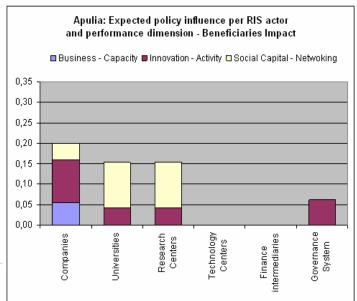

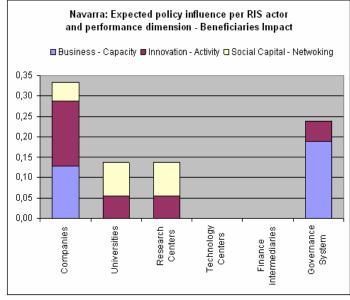

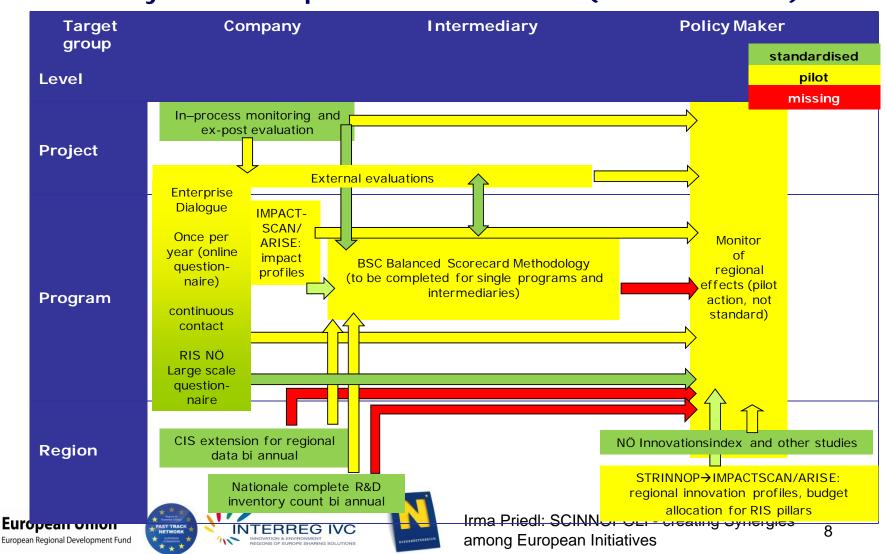








Structuring the current monitoring system and SWOT analysis – example of Lower Austria (current status)
